FedACH Origination and Receipt, the core services for clearing ACH payments, provide financial institutions with scheduled file delivery.

- Select from multiple sorting options, including by item type and/or settlement date, that allow you to group and send multiple items in a variety of ways
- Route files to different receiving points by having certain files delivered to your institution and other files delivered to your processor(s)

Derived Return and Notification of Change (NOC) Functionality via Multiple FedLine Solutions Packages

Enables you to look up a previously received entry, assign the appropriate return reason code or NOC code, then originate the entry back into the network. Returns can be derived for the previous two calendar years.

Timely Notifications of Atypical Activity

Helps financial institutions to monitor for unusual FedACH activity.

- Identifies atypical activity for the current day by using established baselines for your financial institution's historical activity or by comparing your ACH transactions to industry rules
- Sends timely, encrypted email notifications when anomalies are detected, allowing you to address concerns
- Helps you to adhere to Nacha rules and potentially avoid future rule violations
- Offers historical reporting with download capabilities

Use cases:

- **Notifications of change (NOC):** Improve your operations by monitoring when your institution receives the same NOC more than once, outside of prescribed Nacha designated change timeframes
- **Same-day debit large dollar variance:** Gain insight on your Fed account when unusual high-dollar debit batches will settle on the current processing day in the final same-day window
- **Micro-entry return and forward entries:** Monitor velocity of return/forward micro-entries for originators that use small-dollar entries for account verification purposes

- Monitor at the batch level based on either a single processing day or multiple exposure days

FedACH Risk RDFI Alert Service

Available to any RDFI that receives FedACH transactions, regardless of the receiving point or file delivery setup of the financial institution or its service provider.

- Proactively manage potential risks as a receiving depository financial institution (RDFI) and provide ACH information to your receivers

- Obtain information-only notice of unusual or noteworthy conditions within an RDFI's incoming FedACH files, batches, and items

Accomplishes processing, editing, distribution and settlement of virtually any ACH payment during the current processing day.

FedPayments Reporter Service for FedACH enables you to automatically search ACH transactions for ACH information, convert the data into human-readable reports and machine-readable files, and distribute the information within your institution or directly to your business customers.
