Checklist for FedLine Direct Submit DIT test request form to schedule your DIT2 onboarding application testing: Depository Institution Testing (DIT) Application Test Request Form (frbservices.org) On the form, indicate "Other Testing" in the Testing Type section and add "DIT2 Onboarding Testing" in the Additional Comments section at the bottom of the form; a Testing Analyst will be assigned to your organization once this form is Successfully complete the DIT2 onboarding test script provided in the DIT2 Onboarding Guide Receive confirmation email from your Testing Analyst that you have successfully completed the DIT2 onboarding MyStandards Readiness Portal Testing (Available March 2023; prerequisite for DIT2 Testing) Review ISO 20022 sample messages (messages to be provided in stages) Test your own ISO 20022 messages that you would send to the Fedwire Funds Service to ensure there are no schema/technical errors (e.g., missing mandatory elements, correct character length) Successfully complete the test script and submit the attestation form to Fedwire.Funds.Format@ny.frb.org Note: Attestation form must be received before you can begin DIT2 testing.
